

TERMS OF SERVICE, ASSUMPTION OF RISK, AND RELEASE OF LIABILITY

Effective immediately. Binding on every client, guest, talent, and purchaser.

1. Who we are

These terms govern all services, digital products, clothing, bookings, filming, photography, training, moving, tutoring, consulting, and any other work offered by Shop Insane, Insane Comics, Shot By Insane, and EJ Insane (together, “we,” “us,” or “the Company”), based in Charlotte, North Carolina. By booking, paying an invoice, attending a session, appearing on camera, purchasing a product, or using this website, you agree to this document in full.

2. Assumption of risk

You understand that personal training, athletic filming, public-location production, moving labor, and related activities involve inherent risks. Those risks include, without limitation: physical injury, disability, property damage, and death. You voluntarily assume all such risks for yourself and anyone you bring to a session, set, vehicle, gym, or location.

3. Release — injury, death, and property

TO THE MAXIMUM EXTENT PERMITTED BY NORTH CAROLINA LAW, you release, waive, and forever discharge the Company, EJ Insane, and their officers, contractors, and agents from any and all claims arising out of or related to: personal injury; death; lost, stolen, or damaged property; delays; cancelled sessions; or the results of any training, move, shoot, or consult. This release includes claims based on ordinary negligence. It does not waive liability for willful or wanton misconduct where such a waiver is prohibited.

4. Right to refuse or end service

We may refuse, pause, or immediately terminate any booking, shoot, session, or sale — with or without a refund at our discretion — if we reasonably determine that the environment is unsafe or unprofessional. Grounds include, without limitation:

- Display, brandishing, or careless handling of firearms, replica weapons, or other weapons in a manner that creates an unsafe working environment, or that is not pre-cleared in writing as a controlled production prop under a safety plan.
- Impairment from alcohol, cannabis, or any other substance that, in our judgment, compromises safety, judgment, or the ability to take direction.
- Illegal activity; threats; harassment; or conduct that endangers crew, talent, bystanders, or property.
- Failure to follow on-set or session instructions. We are not obligated to remain in any location or continue any engagement once those conditions appear.

5. Production, likeness, and locations

Unless a separate written contract says otherwise, you grant us a non-exclusive license to use footage and stills of work we create for portfolio, marketing, and the Insane Comics / Shot By Insane brands. You confirm you have the right to be filmed or photographed at the location you provide, and that you will obtain any permits or releases required. You are responsible for the conduct of guests you invite.

6. Digital products and billing

Digital products are delivered as-is after payment. All sales of digital goods are final once access is granted. Invoices issued by Shop Insane Billing are due as stated. Chargebacks filed in bad faith after delivery of services or files may be contested with this agreement, the invoice, and session records. Hourly services are billed for time reserved, not only time used, once the window

begins.

7. Editing packages

Editing is sold as a flat package: Short Form (finished video under three minutes) or Long Form (finished video three minutes or longer). Scope beyond the agreed cut, extra revisions outside what was booked, or new source footage may be invoiced separately.

8. No professional advice beyond the engagement

Business consults, content strategy, and educational products are opinion and instruction, not legal, tax, medical, or licensed financial advice. Training is not medical treatment. You should consult licensed professionals for those matters.

9. Indemnity

You agree to indemnify and hold the Company harmless from claims, damages, and reasonable attorneys' fees arising from your breach of these terms, your guests' conduct, or your use of locations, props, or weapons you control.

10. Governing law

This agreement is governed by the laws of the State of North Carolina. Exclusive venue is the state or federal courts located in Mecklenburg County, North Carolina. If a court finds any clause unenforceable, the rest remains in force. This document is intended for production to law enforcement or a court as evidence of the parties' agreed allocation of risk.
